4CORE provides weatherization services in a 5 county region in SW Colorado with a grant awarded by the State of Colorado Governor's Energy Office. During 2010, the Organization weatherized 190 homes bringing in approximately \$1,600,000 to the local Four Corners Area. Through these weatherization services, residents were able to save almost \$78,000 a year in utility bills.

4CORE experienced exponential growth and continued mission expansion in 2010. The Organization organized 15 Sustainable Building Education Program sessions in which 450 attendees were present. There were 308,000 in rebates to 272 community residents and businesses. During 2010, the Organization received more than 13,600 inquiries via phone calls, e-mail, web site visits, newsletter subscribers, twitter followers, and presentation attendees.
